UNITEHERE MIDWEST JOINT BOARD WORKS TO EXPAND UNEMPLOYMENT BENEFITS TO WORKERS

UNITEHERE Midwest Joint Board representatives helped push along the expansion of access to unemployment for members and non-members who have been displaced or laid off due to the Coronavirus. The Governor expanded unemployment benefits from 20 week to 26 weeks and expanded those who are eligible. The Governor also expanded the time worker had to file for unemployment from 14 to 28 days.



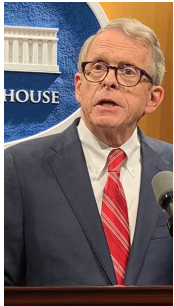
UNITEHERE Midwest Joint Board meets with Governor to fight for Part-Time Tipped Workers

UNITEHERE Midwest Joint Board has been in contact with the Governor's office in an attempt to find a way to ensure that tipped workers that work part time are able to maintain their normally expected income. Local 24 representatives have also

been working with State House representatives and the Michigan AFL-CIO to find ways to make sure that union and non-union part time tipped workers are able to still feed their families and have guaranteed healthcare coverage.

OHIO

Governor of Ohio Expands unemployment and closes polling locations



The Governor of Ohio, along with his health director, postponed the Ohio Presidential Primary in order to protect workers and families. He also, expanded the availability of unemployment benefits and waived the week long waiting period to file for those benefits. This extends to workers who are being negatively impacted by the spread of the virus.

Ohio Unemployment

UNITEHERE Midwest Joint Board Workers Fall Under Expanded Unemployment Benefits in Ohio

UNITEHERE members who have entered laid off status are encouraged to apply for unemployment. With the Governor expanding unemployment benefits members, even those who are getting paid for two weeks, are encouraged to file in order to make sure they do not miss a week of pay. Local 24 representatives have been in conversations with policy leaders

in Ohio and based on those conversations it has been confirmed that any worker who is deemed "laid off" because of the mandated shut downs or voluntary shut downs due to COVID-19 they are encouraged to file for unemployment so they can continue to provide for their families in this time of uncertainty.
